Pursuant to Board policy, you and/or the Georgia Department of Community Affairs have fifteen (15) days to respond in writing if you choose to do so. The Board will perform an initial review of the complaint to determine if there is a basis to proceed. Should the Board determine that there is no basis for proceeding on the complaint, the Board will notify you and the complaining party that the complaint will be dismissed without further action by the Board. If the Board determines that there is a basis to proceed, the complaint will be set down for an initial hearing before the Board. You and the complaining party will receive notice of the date and time of the initial hearing pursuant to the Board's Rules.
